- SERIAL NO: All Models with Version 4 Computer Curve Liner
- **SUMMARY:** Jackson Service Bulletin #297, issued in May of 1998, listed Version 4 Computer Curve Liner components which could only be repaired by sending them to the Vendor. There are now several more components which have become obsolete.

Because of the number of obsolete components that make up the Version 4 Computer Curve Liner, we can no longer repair them.

Conversion Groups are available to upgrade Version 4 Computer Curve Liner to Version 6 Computer Curve Liner.

- **OPERATIONAL IMPACT:** Repairs to Version 4 Computer Curve Liner are no longer available.
